INTRODUCTION

- ❖ The election of Indonesian presidential candidates and vice presidents has been a warm conversation among Indonesians. All candidates have their own visions to offer to voters, including their visions and views of indigenous peoples, agricultural policies, and natural resources.
- ❖ The fourth debate was filled with panel questions submitted by the moderator to the three chairmen. Their response was a little tense, and the chairpersons sent them a series of speeches, while the debate was a formal one. Therefore, the style of language in this political sphere has become important to study.

LITERATURE REVIEW

1. A language style is a way of expressing thoughts through language in a typical way that shows the soul and personality of the language user. (Keraf, 1991:113).
2. Acts assault (speech act). Speech is a personal or individual symptom of a psychological nature determined by the language ability of the speaker in the face of a particular situation. (2000:53).
 - a. The act of assertive or representative explanation serves to inform or explain something to the listener with the expectation that he or she will receive and understand the information as true. Yule (2000:53), Koizumi (1995:149)
 - b. A directive act is a type of act performed by a speaker with the aim of making the listener perform a certain act. Yule (2000:54), Koizumi (1995:150)

METHOD

The method used in this research is qualitative descriptive. The data used is a list of candidate vice presidents from the dialogue discourse at the fourth question-and-answer session in the 2024 debate on the deepening of the mission's vision and programme of work related to indigenous issues, agricultural policy, and natural resources. The data consisted of twenty-five trials consisting of six trials of presidential candidates of the number one trial, ten trial trials, and nine trials. The data is analyzed using pragmatic stylistic approaches in Simpson and Yule's view. The study aims to describe and formulate the use of language style in assertive obedience and directive by the three candidate vice presidents in the 2024 debate.

FINDING AND DISCUSSION

Context :

This question is based on the “government” behaviour that treats indigenous peoples, agri-policy, and natural resources often without the consent of Indigenous people as a result since 2014 there has been looting of 8.5 million hectares of indigeno territory resulting in 678 cases of criminalization and impoverishment of Indian women.

Research has identified that the candidate vice president of the number one candidate pair uses seven times the ironic style of language in the following statement and one time the hyperbolic style in the affirmative style. The style of sinekdoke language, satire, cynicism, and irony used by the respondents in conveying their responses aimed at ethical improvement, while the style of irony and hyperbolic language used by chawapres number two aims at ridicule.
